Total emissions have increased due to business growth. The emissions intensity by revenue has reduced from 62.5 tCO₂e/£m revenue in 2019 to 61.2 tCO₂e/£m revenue in 2025.

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 38.3 tCO₂e by 2030. This is a reduction of 52.4 % compared with our baseline in 2019.

Progress against these targets can be seen in the chart below:

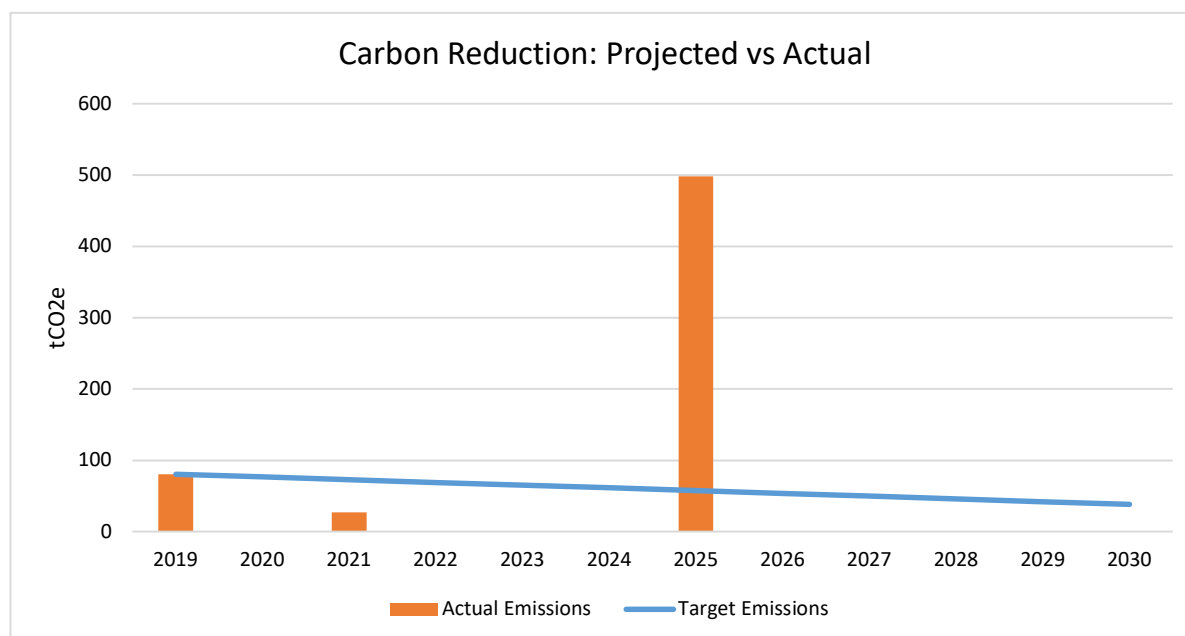


Chart shows Location based total
